Dear Sisters and Brothers:

It is with great pleasure that we are notifying you the General Executive Board of the International Association has decided to restore full autonomy to Local Union No. 721, Toronto, Ontario, as of April 18, 2018.

The General Executive Board further decided the following:

1. Local Union No. 721 shall hold nominations for Local Union Officers at 6:00 p.m. on Wednesday February 21, 2018 at the Oasis Catering and Convention Center, Mississauga, Ontario, due to the ongoing construction at the union hall.
2. Local Union No. 721 shall hold their election of Local Union Officers on Saturday, March 31, 2018 from 7:00 a.m. to 5:00 p.m. at the Oasis Catering and Convention Center, Mississauga, Ontario. The term of office will remain in effect until the regularly scheduled election of local union officers is held in March 2023.
3. The By-Laws of Local Union No. 721 will be amended to permanently change the dates of nominations and election to February and March, respectively. The By-Laws will also be amended to include any other changes made to the standard form Local Union By-Laws established by the General Executive Board. The revised By-Laws of Local Union No. 721 will become effective on Wednesday, April 18, 2018 after the swearing-in of the new officers is held.
4. Full autonomy will be restored to Local Union No. 721 effective Wednesday, April 18, 2018, provided that the election of Local Union Officers has been certified and a full slate of Officers is in place. As such,

all regular membership meetings, Executive Committee meetings and other meetings of the Local Union shall be held in accordance with the International Constitution and Local Union By-Laws.

5. The duly elected officers of the Local Union will be sworn in at the next regular meeting scheduled to be held on Wednesday, April 18th, 2018 at 6:00 p.m. The Local Union Officers should be reminded that all the officers are to keep themselves in continuous good standing with their dues payments during their tenure of office as elected officers.

We would like to take this opportunity to extend our appreciation to all the membership for your cooperation during the period of International Supervision.
